The exceptions are: Section G, J, K, L, M, N and S (class 5 -19 and 57 -74) which are to be brought in no later than 2pm on Friday 6<sup>th</sup> March and Section H (pets) by 10.30am Saturday 7<sup>th</sup> March.

## EXHIBIT REGULATIONS AND BY-LAWS

The Regulations of The Royal Agricultural Society (Inc.) shall apply to this show except where otherwise stated

1. Every exhibit must be grown by or be the work of the exhibitor and an exhibitor may be called upon to make an affidavit to that effect.
2. Exhibitors or their agents, when called upon by the stewards of the society, shall prove the correctness of their entries.
3. All entry FORMS must be accompanied by entry fees and made not later than 4pm Wednesday, 4<sup>th</sup> March. Please read information at the front of each Section.
4. All entries must be made on the society's form of entry.
5. Exhibits may only be entered twice in consecutive years and must not have won a prize at previous shows.
6. The committee reserves the right of refusing or cancelling any entry without giving reason for doing so.
7. The judges may withhold prizes for such exhibits, as they deem unworthy.
8. Should only two exhibits be shown in any one class, no second prize will be awarded, unless in the opinion of the judge such exhibit could have gained a prize had there been further competition.
9. No appeal against the decision of the judges will be entertained unless made in writing before 2.00 pm on Show Day and a deposit of \$5.00 will be lodged. Appeal to be lodged at the office of the Secretary.
10. Livestock exhibits must not be removed until after the Grand Parade and Produce not before 4.00pm on the day of the show and then only by permission of the stewards. The steward in charge of any section may in his opinion if it is necessary, grant permission to remove an entry before the stated time.
11. Exhibits, except where otherwise stated, must be in their allocated places not later than 9.00am on the day of the Show. Horses in action must be on the ground at least half an hour before the advertised starting time for the event for which they are entered.
12. Exhibitors will arrange their exhibits under the direction of the stewards and no exhibits shall afterwards be moved or attempted to be moved without the sanction of the stewards.
13. EXHIBITORS: Please refer to section being entered for closing times for entry forms and staging of exhibits.
14. Except where otherwise stated, judges will enter upon their duties at 9.00am on Show Day. The judges will sign the Steward's award book.
15. Any person insulting or interfering with the judges during the Show will be subject to removal from the ground and the prize (if any) awarded to such person may be absolutely forfeited to the Society.
16. Attendants at all times during the Show shall be under the control and direction of the stewards in their respective sections.
17. No exhibits will be allowed to compete in more than one class, except where otherwise stated
18. All cattle and horses must be led to their respective stalls.
19. Every reasonable care must be taken of exhibits, but no responsibility will be incurred by the society.
20. Ordinary precautions will be taken to guard against fire or theft to protect the property of the society and the exhibitor, but the society will not be responsible for any accident that may be caused through an exhibitor and it shall be a condition of entry that each exhibitor shall hold the society blameless and indemnified against any legal proceedings arising from such accident.
21. Persons contravening any of the Society's rules or regulations shall forfeit any prizes which may be awarded them.
22. All persons entering the showgrounds on Show Day shall pay the entry fee of the day excepting: Those in possession of a members ticket. Children of a member, school age and under 16 years. Official guests of the Society
23. At the discretion and under instruction of the committee, refunds of admission prices paid will be made by the Secretary at the showground office to workers on the ground.
24. **ALL OTHER ADMISSIONS TO BE CHARGED FOR ENTRY INTO THE SHOWGROUND.**
25. **DOGS ARE NOT PERMITTED ON THE SHOWGROUND - NO EXCEPTIONS**
26. All persons other than Financial Members and those issued with a complimentary pass, must pay to enter the gate during the show, whether being an exhibitor or not.
27. Section winners are reminded that a short note of 'THANKS' to the donor would be appreciated. If you do not have the address, letters may be left with the Secretary.
